The Community Council resolved to strongly OBJECT to the proposed removal of the planning conditions contained in the above planning application. As the City & County of Swansea are aware, all of the planning conditions of the original determination in Planning Permission 2007/1250 granted on the 11 December 2007 were considered to be imperative & absolutely necessary to safeguard the Bryntywod area.

The Community Council, wish to Object to the above Planning Application on the following grounds:-

- (1). the proposed removal of the stipulated planning conditions would have a significant adverse effect on the environment & visual impact on the surrounding residential properties in the area, especially in Bryntywod.
- (2). the proposed removal of those conditions especially those relating to the hard standings & height of stacked materials on the site, surface drainage of the site abutting the existing Afon Llan, which then discharges to the River Loughor all these conditions were to prevent fire hazards on the site, to protect the existing waterways & surrounding environment.
- (3) the removal of the requested conditions are tantamount to being ridiculous especially in view of the extension of the use of the site for the reclamation of waste carpets, street sweepings etc.
- (4). the effect of the removal of such conditions could seriously affect the wildlife habitat around the site.

I have also been requested by the Community Council, to ask where the City & County of Swansea has been in enforcing all of the Planning Conditions of the original planning consent, since 2007.
