12. Llangyfelach Ward Councillor Update (Verbal)

Councillor Gareth Sullivan, Llangyfelach Ward Councillor on Swansea Council will provide a verbal update relating to his Ward work.

13. Planning Applications & Planning Matters - Swansea Council (Verbal)

14. Highways, Footpaths, Cycleways & Bridleways - Swansea Council

a) Road Safety - Crossing B4489 at Junction of Swansea Road & Pengors Road, Llangyfelach

The Clerk and Councillor Gareth Sullivan have been in communication with Swansea Council as instructed. Swansea Council, Highways have provided an update to the Council's request for a crossing at the junction of Swansea Road and Pengors Road.

Swansea Council's, Group Leader Traffic & Highway Network Management has stated that he understands the concerns of the local community and that Officers have actively sought to secure Section 106 funding to meet the local community's aspirations for a signal-controlled crossing. However, certain conditions need to be met in the development of the proposed housing estate before the Section 106 monies are released. It is unfortunate that Swansea Council are unable to deliver a crossing immediately, however, Officers have made best endeavours to ensure that a crossing will be eventually installed on Swansea Road.

He also committed to the following:

- i) To examine the Speed Indicator, display signs to ensure they are working correctly.
- ii) To closely monitor vehicle speeds along this section of Swansea Road by arranging for vehicle speed surveys to assess the scale of the issue. This data will be analysed and where appropriate shared with our partner organisations GoSafe and South Wales Police to jointly consider any further actions. The survey will take

the form of pneumatic tubes laid across the road linked to a data recorder for a period of 72 hours.

There will be two speed surveys undertaken. One in the coming weeks, subject to the Survey Team's workload and a second in September 2021 when the school reopens after the summer recess. It is hoped that the second survey will more accurately reflect vehicle volumes and speeds at 'normal' levels if and when all Covid travel restrictions are lifted.

iii) To keep the Community Council apprised of speed survey data, any resulting actions, and timescales for the implementation of the crossing as the Section 106 trigger point approaches.

Recommended that:

1) The update be noted.

15. Playground at Llysgwyn / Bryn Glas, Llangyfelach

The works at the park have been completed.

16. Playground at Fairview Road - Community Budget Capital - Play

Councillor Gareth Sullivan and Peter Gibson have worked with Swansea Council to secure funding to supply and install new play equipment at Fairview Road playground.

They have secured funding from Swansea Council for:

- Zipwire.
- Carousel.
- Seesaw.
- Double Frame Swing (Two Flat Seats and One Basket Seats).
- Double Frame Swing (Two Cradle Seats and One Tango Seat).
- Multi-User Springer (Double).
- Climbing Centre (Slide, Climbing Wall, Pole and Rope Net multi access points to include one point for easy access points).

Recommended that:

- 1) The update be noted.
- 2) Councillors Gareth Sullivan and Peter Gibson be congratulated and thanked for their work to secure the funding.
- 3) Swansea Council be thanked for making the funding available for the benefit of the community of Llangyfelach.

17. Defibrillator at Junction of Heol Pentre Felen & Bryn Hedydd

Swansea Council have confirmed that bollards mut be placed either side of the proposed defibrillator at the junction of Heol Pentre Felen & Bryn Hedydd prior to its installation. As a gesture of goodwill and in line with Swansea Council's aim for Swansea to become the UK's first Defibrillator Friendly City, they will install the bollards at cost price which is approximately £600.

Recommended that:

1) The Swansea Council be instructed to install the bollards which will be paid for by Llangyfelach Community Council.

18. Defibrillators within the Llangyfelach Community Council Area

Discussions between the Council, Heartbeat Trust UK and other relevant parties are continuing.

a) Griffiths Waste Management, Bryntywod
Councillor Phil Crayford will provide a verbal update.

b) Defibrillator at Llangyfelach Church Hall

Swansea Council Officers met several Councillors onsite. It is suggested that the Defibrillator be re-sited slightly, taking it closer to the Church Hall entrance. Councillor Gareth Sullivan has agreed to use his Swansea Council Community Budget to pay for bollards to be placed around the Defibrillator. These actions should address of the problem of indiscriminate parking, restricting access.

The Chair of Council, Councillor Peter Gibson has liaised with the Church to obtain permission to re-site the Llangyfelach Church Hall defibrillator. The Church are fully supportive.

Recommended that:

- 1) The update be noted.
- The Clerk instruct Phillips Services (Wales) Ltd to move the electrical supply for the defibrillator subject to the Church giving authority.
- 3) Councillor Gareth Sullivan be thanked for using his Community Budget to fund the bollards.

19. Training (For Information)

The Clerk referred to the monthly One Voice Wales Remote Training Schedule. Councillors and the Clerk should regularly review their training requirements and were urged to consider training as required. Should a Councillor wish to attend training they should liaise with the Clerk.

20. NHS, Social Care & Frontline Workers Day - 5 July 2021

a) Flagpole at Llangyfelach Church Tower

The Chair of Council and Clerk have been seeking a company to refurbish the flagpole, its fixing and to re-erect it. To date this has proven difficult, however Councillor Sharon Phillips has offered for her company to assist as they have done similar work with the former Weathervane on the Church Tower.

Recommended that:

- 1) The update be noted.
- 2) Councillor Sharon Phillips in consultation with the Chair of Council and Clerk be authorised in carry out the works to the flagpole.
- b) NHS & Keyworkers Rainbow commemorative bench on the Village Green The Clerk stated that he had ordered the bench and had obtained a quote of approximately £1,800 from Swansea Council to install it. The usual practice for bench installation is that Swansea Council would take on ownership of the bench and if it were damaged, then the bench would be removed and not replaced.

Recommended that:

- 1) The update be noted.
- 2) Swansea Council be instructed to install the bench.
