1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2020-21 was £8.32 per elector.

In 2020-21, the Council made payments totalling **£1,500** under section 137. These payments are included within 'Other payments' in the Accounting Statement.

My audit has been conducted in accordance with guidance issued by the Auditor General for Wales.

Audit opinion

On the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's/Committee's governance arrangements; and
- that the Council/Committee does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Other matters arising and recommendations

I draw the Council's attention to the following matters and recommendations arising from my audit:

- The comparative 2019-20 accounts reported in the Statement of Balances section of the Accounting Statement incorrectly record the Cash and bank balance (line 9) and the closing balances (line 11) as £51,769. These lines should state £26,422. The Council has incorrectly recorded the balance per the bank statement here rather than the reconciled cashbook balance. This results in a discrepancy between the Statement of receipts and payments and the Statement of Balances.
- We recommend that in future years, the Council checks the arithmetic and consistency of the accounting statement before approval.
- Further information and guidance on preparing the accounts is contained in Governance and Accountability for Local Councils in Wales: A Practitioners' Guide.


