Audit opinion – Unqualified

On the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Other matters arising and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the body.

Rounding error in accounts

Line 9 and 11 have been rounded to £33,173. This means there is an inconsistency between lines 7 and 11. We recommend that the Council checks the arithmetic accuracy and consistency of the accounts before approval.

2021/22 Precept

The Council approved a precept on 07 January 2021 for £24,000 but the request made to the Unitary Authority was only £23,500.
